Masters Division competes only at the District level – entrants do NOT advance.

Everyone must compete in their own age division except those who exceed the maximum weight.

Length of bouts: Intermediate, Advanced, Elite, and Open – three 1½ minute periods. All others – three 1 minute periods.
Overtime – one 1 minute period followed by 30 second ride-out period if necessary.

Wrestling rules: Modified PIAA rules, PIAA officials will be used. EVERYONE must have PROOF OF AGE if challenged INCLUDING the person issuing the challenge.

Important: Once you have qualified for the regional tournament, you MAY NOT enter another district tournament. Anyone who does will be disqualified from advancing to the regional. Any entrant who falsifies information on an application to enter a district or regional MAWA tournament will be subject to a one year suspension from the program, effective immediately upon discovery.

Awards: Medals will be given to the top four finishers in each weight class.

Uniform: One-piece singlet or two-piece uniform is REQUIRED.

Please - no call-in or email registrations.

Admission for spectators will be charged at the door. Hot food and snacks will be available throughout.

The top FOUR place winners in this tournament advance to the Western Regional Tournament April 19 & 20 at York Expo Center, York, PA. There is a \$15.00 advancement fee to be collected at the District Tournament. One pound allowance given at the regional tournament.

The top FOUR place winners in the Regional Tournament advance to the MAWA's Eastern National Championships May 4 & 5 at Wicomico Civic Center, Salisbury, MD. There is a \$15.00 advancement fee to be collected at the Regional Tournament. Fifth and sixth places are alternates. An additional one pound allowance (two pounds total) will be given at the championships.

This MAWA Tournament is NOT affiliated with the AAU. No AAU card is required to participate in this program.
