RULES: P.I.A.A. MODIFIED RULES **NOTE: Once you have qualified for the Regional Tournament, YOU MAY NOT enter another District tournament. Anyone who does WILL BE disqualified from advancing to the Regionals. Any entrant who falsifies information on an application to enter a district or regional MAWA tournament will be subject to a one-year suspension from the program, effective immediately upon discovery.**

LENGTH OF BOUTS: OPEN, ELITE, ADVANCED, and INTERM: 3- 1 ½ minute periods

BANTAM, MIDGET, JUNIOR: 3-1 minute periods

Overtime sudden death tie-breakers: One 1 minute period followed by a 30 second ride out period if necessary.

AWARDS: Medals for top FOUR finishers in each weight class ***** CAFETERIA WILL BE OPEN ALL DAY *****

The top **FOUR** place winners in this tournament will advance to the Southern Regional Championships to be held on April 13TH and April 14TH at the **Wicomico Civic Center, Salisbury, MD. including Open division. There will be a \$15.00 advancement fee to be collected at the District Tournament. A 1 lb. weight allowance will be given at the Regional Tournament.**

The top **FOUR** place winners in the Regional Tournament advance to the Middle Atlantic Wrestling Associations Eastern National Championships at the **Wicomico Civic Center, Salisbury, MD on May 4TH & May 5TH, including open division. There will be a \$15.00 advancement fee to be collected at the Regional Tournament. Fifth and Sixth places are ALTERNATES. An additional 1 lb. weight allowance (2 lb. total) will be given at the Eastern National Championships.**
