Friday, April 10 1-3 p.m. ONLY for Advanced, Elite, Open

Saturday, April 11 8:00-8:30 a.m. ONLY for Open

NOTE: Absolutely NO air mattresses or canopies will be allowed in the building. Camp chairs only will be permitted.

**Starting Times**:

Friday, April 10 8:00 a.m. for Bantam, Midget, Junior, Intermediate

Saturday, April 11 8:00 a.m. for Advanced, Elite - approximately 10:00 for Open

Rules: Scholastic rules with minor exceptions. (Director has final authority)

Awards: Medals for top four place finishers.

Uniforms: HEADGEAR and singlets or 2-piece uniform required. (Open Division exceptions permitted)

<u>Eligibility</u>: Must have placed top four in a <u>WEST</u> District Tournament.

<u>Important</u>: Once you have qualified for the Regional Tournament, you may not enter another District Tournament. Anyone who does will be disqualified from advancing.

<u>Advancement</u>: The top four in the WEST Regional will advance to the Middle Atlantic Eastern National Championships to be held on May 2<sup>nd</sup> & 3<sup>rd</sup> at the Wicomico Civic Center, Salisbury, MD. A **\$20** advancement fee will be collected. There will be a match to decide 5<sup>th</sup> & 6<sup>th</sup> place to serve as alternates for Eastern Nationals.

Admission: \$10 for each day for Adults and \$5 each day for Students.

<u>Proof of Age</u>: Proof of age must be carried by all contestants at all tournament levels. Any challenge of age requires each wrestler to produce age documents at the time of the challenge, or no challenge is allowed.
